Hotel after hotel in Świeradów brought speeding traffic, higher costs, and dry wells. No more being a free backdrop for developer millions!

⚡ HOW MUCH MORE MUST WE PAY FOR OUTSIDE PROFITS? TIME TO SAY: STOP!

Our community has already borne the heavy burden of Świeradów's expansion: weekend speedways, noise, and dropping groundwater, forcing residents to fund deeper drilling and connections out of their own pockets! Who made millions? The developers. What did our village get? ZERO!

Now across 16.5 ha in the 'Jerzy' quarry, they plan a 50 m hotel tower and housing estates. Do not be intimidated! We pay taxes, and remember: LOCAL OFFICIALS AND COUNCILORS ARE PAID TO REPRESENT THE PEOPLE, NOT THE DEVELOPERS! We demand FAIRNESS and real improvements to our lives!

💧 1. PROTECTING WATER & WELLS

Świeradów already drained local groundwater, making wells insecure! If the resort starts pumping, taps will run dry. WE DEMAND: The developer must fund a new municipal water supply network for local residents BEFORE opening any hotel!

🚗 2. STOP THE WEEKEND SPEEDWAY

The route to Świeradów has become a dangerous speedway for tourists. Without sidewalks, fatal accidents will happen! WE DEMAND: Construction of illuminated sidewalks, crossings, and traffic-calming roundabouts funded by the developer BEFORE opening!

🚛 3. PROTECT RURAL DIRT TRACKS

Heavy aggregate trucks will shatter narrow village tracks (including parcel 51). WE DEMAND: A strict ban on heavy machinery on rural lanes (access strictly via DW 361) and developer-funded road paving (Art. 16).

💰 4. FAIR VILLAGE BENEFITS

Big business makes millions from our landscape – the village must not be left with nothing! WE DEMAND: A dedicated Village Development Fund for Orłowice & Krobica, street lighting, sewage networks, and real community support!

PL A PERSONAL WORD FROM A NEIGHBOUR — WHY I AM SPEAKING UP (Jan Fura, Orłowice 24):

I was born in the UK, but Polish blood runs in my veins. My father was a war refugee forced into exile, and my grandfather fought proudly for a free Poland at the Battle of Monte Cassino. My first profound memory of pride in my heritage was watching the courage of the Polish people in the 'Solidarność' movement, standing tall against unfairness and totalitarian power. My father always taught me: 'To be truly free, you must use your rights before they are taken away!'.

I know it can be intimidating to stand up to big developers and the Town Hall. Some might whisper: 'He is an Englishman, he doesn't understand how things work here'. I understand perfectly – I was raised in Polish culture and tradition. Poland is the homeland of my family, and Orłowice is my conscious choice and my home. I am not standing against anyone, but standing shoulder to shoulder with you in the spirit of true Polish solidarity, fairness, and the defense of our community's future.

STEP 1: GET THE FORM

Collect the pre-filled, simple 1-page objection form from the Sołtys or neighbours in Orłowice.

STEP 2: SIGN IT (1 MINUTE)

Write your name, address, and signature. This is a lawful petition – no one can penalize you!

STEP 3: RETURN BY 9 OCTOBER

Return it to the Sołtys or leave at Orłowice 24 – we will file them together at town hall before the deadline!

⚖️ LEGAL POWER: If the Mayor rejects our demands, Town Councilors MUST vote on each objection BY NAME at the Council session!
